

2018 January Term Information Sheet

Financial Aid may be available to eligible students according to the conditions and requirements listed below.

- ✓ For Financial Aid processing, the J-Term is considered a part of the spring 2018 term.
- ✓ You must be registered for all the courses for which you intend to enroll *before* submitting the January Term Aid Application. **The deadline to submit the January Term Application is Friday, January 5, 2018.**
- ✓ You must have filed the 2017-2018 Free Application for Federal Student Aid (FAFSA) before your January Term aid eligibility will be reviewed.
- ✓ You will only be eligible to borrow a Federal Direct Stafford Loan if you have not used your full annual loan eligibility in 2017-2018 and are enrolled in at least six credits between J-Term and spring. We will award the loan based on the additional charges associated with January Term.
- ✓ Students who do not have 2017-2018 Federal Direct Stafford Loan eligibility remaining may ask their parent to consider applying for a Federal Direct PLUS loan (parents of dependent students only) or you may consider applying for a private alternative loan to help cover J-Term charges. - ✓ Textbook Deferments are **not** available during the January Term.
