

2026 January Term Information Sheet

Financial Aid may be available to eligible students according to the conditions and requirements listed below.

- ✓ For Financial Aid processing, the J-Term is considered a part of the Spring 2026 term.
- ✓ Students must be registered for all the courses for which they intend to enroll *before* submitting the January Term Aid Application. The deadline to submit the January Term Application is Friday, January 23, 2026.
- ✓ Students must have filed the 2025-2026 Free Application for Federal Student Aid (<u>FAFSA</u>) before their January Term aid eligibility will be reviewed.
- ✓ Students will only be eligible to borrow a Federal Direct Loan if they have not used their full annual loan eligibility in 2025-2026 and are enrolled in at least six required credits between J-Term and Spring. The loan will be awarded based on the additional charges associated with January Term.
- ✓ Students who do not have sufficient funds from their Spring 2026 awards to cover J-term charges, may consider asking a parent to apply for a Federal Direct PLUS loan (parents of dependent students only), or students may consider applying for a private alternative loan to help cover J-Term charges. - ✓ Students are reminded to always borrow conservatively.
- ✓ Textbook Deferments are <u>not</u> available during the January Term.
